Adult Safeguarding Policy

This policy is concerned with our work with adults, and in particular, vulnerable adults. These are classed under the **Care Act 2014** as:

- Over 18 years old
- Need care and support (regardless of whether the local authority is meeting these needs)
- Experiencing, or at risk of, abuse or neglect
- Adults who are unable to protect themselves from abuse or neglect

As a West Midlands based company, we follow the guidance of **West Midlands Adult Safeguarding Information Hub** (see resources section below).

In line with the Care Act, we follow the following 6 rules:

- **Empowerment** supporting individuals to make their own choices and decisions
- Prevention raising awareness of what abuse is and the processes in place to prevent this
- **Proportionality** in line with the level of risk
- Protection representing individuals during the safeguarding process
- Partnership working with individuals, families, health and social care and other professionals
- Accountability taking responsibility for one's actions

We recognise that abuse can take many forms including:

- Physical
- Psychological
- Sexual
- Domestic
- Discriminatory
- Neglect
- Financial / Material
- Organisational
- Radicalisation (see PREVENT section below)

and that the risk of these happening is increased in people who are vulnerable, as described above.

The **individual** is at the centre of this policy and our way of working. We don't make assumptions on people's capacity to make decisions based on our own opinions. We will act with regard to their wishes and feelings and make judgments based on benefits and burdens upon individuals.

PREVENT

Radicalisation: Some young people and adults at risk of harm may be vulnerable to radicalisation for the purpose of violent extremism. Concerns regarding radicalisation will be referred to **Channel** which is a multi-agency panel who offer guidance and support with the aim of preventing activity which could be deemed as criminal.

Channel is chaired by the local authority. Meetings are held on a monthly basis. If you have any concerns about someone and would like more advice please contact the Community Safety Team by sending an email to **safer@wolverhampton.gov.uk** or Telephone on **01902 551214.**

Extremism goes beyond terrorism and is defined in the Governments Counter Extremism Strategy as vocal or active opposition to our fundamental values including the rule of law, individual liberty and the mutual respect and tolerance of different faiths and beliefs. The calls for the death of armed forces is also considered as extremism.

- Listen Carefully
- Reassure
- Be supportive
- Tell them what will happen next
- Report our concerns
